## Young Composers Award 2010

### 2010 FOCUS IS ON VERSATILITY

### FINANCIAL PRIZE AT \$ 2500

**Composition Requirements:** 1) The 2010 requested work will be a Song Cycle for solo and piano. Details: a set of three pieces 'related in thought and character', performable as separate pieces OR as a unit, with or without narrator. The work should be of approximately 12 minutes duration. It should be entirely in Hebrew, using texts from Jewish liturgy, (Sabbath, Festivals, High Holy Days or a combination of the three. While the completed work should be suitable for concert presentation in whole or in part, its separate pieces should also be usable for religious services. In this regard, it is permissible to include congregational responses if the composer so wishes.

2) Scores must be legibly copied or printed in full by the composer and contain all necessary dynamics, tempi, etc. (chorded "charts" or tapes are unacceptable). The composer's name should appear only on the first page of the score.

3) Candidates may submit more than one entry in any given year. New submissions may be sent to future YCA competitions, but no candidate may win the award more than twice.

4) Submitted pieces must have been written no earlier than one year before the submission date, and be unperformed as well as unpublished.

### The Award:

- ♫ A \$2,500 cash prize;
- ♫ A premiere performance at the annual convention of the American Conference of Cantors/Guild of Temple Musicians in Memphis, Tennessee, during June 27-July 1, 2010 (specific date tba);
- ♫ Transportation and accommodation costs within North America for the winning composer to attend the premiere, at which he/she agrees to be present;
- ♫ Automatic submission of the winning piece to Transcontinental Music, for publication consideration;
- ♫ One year's free membership in the Guild of Temple Musicians.

**Qualifications of Candidates:** Applicants should be Jewish composers from any country, at least 18 years of age by the submission date, and born on or after January 1, 1975.
