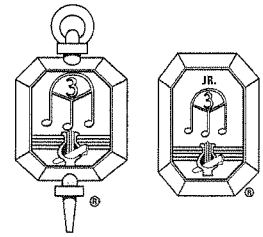


Tri-M[®] 2008–2009
